- The Board shall provide for a system-wide testing program which shall be periodically reviewed and evaluated. The purposes of the program shall be to:
 - 1. Assist in promoting accountability;

562. Determine the progress of students;

3. Assess the effectiveness of the instructional program and student learning;

- 4. Aid in counseling and guiding students in planning future education and other endeavors;
- 5. Analyze the improvements needed in each instructional area;
- 6. Assist in the screening of students with learning difficulties;^{1,2}
- 7. Assist in placing students in remedial programs;
- 18 8. Provide information for college entrance and placement; and 19
- 9. Assist in educational research by providing data.
- The Director of Schools shall be responsible for planning and implementing the program, which includes:
- 1. Determining specific purposes for each test;
- 25 2. Selecting the appropriate test to be given;
- 27 3. Establishing procedures for administering the tests;
- 4. Making provisions for interpreting and disseminating the results;
- 5. Maintaining testing information in a consistent and confidential manner; and
- 6. Ensuring that results are obtained as quickly as possible, especially when placement in a special learning program might be necessary.
- State-mandated student testing programs shall be undertaken in accordance with procedures published by the State Department of Education.³

- TNReady⁴ and EOC⁵ scores will be included in students' final grades as follows: 1 a) Grades 3-5 - 0 % of the student's final grade 2 b) Grades 6-8 - 10% of the student's final grade 3 c) Grades 9-12 - 25% of the student's final grade 4 5 The Director of Schools may exclude these scores from students' final grades if results are not 6 received by the district at least five (5) instructional days before the end of the course.^{4,5} 7 INTEREST INVENTORIES AND CAREER ASSESSMENTS 8 Interest inventories will be made available to students in either the 7th or 8th grade. These may 9 include assessments such as the Kuder assessment, Myers-Briggs Type Indicator, the ASVAB, 10 or the College Board Career Finder. 11 Career aptitude assessments shall be administered to students in either the 7th or 8th grade in 12 order to inform the student's high school plan of study. 13 14 TESTING INFORMATION AND PARENTAL CONSENT Any test directly concerned with measuring student ability or achievement through individual or 15 group psychological or socio-metric tests shall not be administered by or with the knowledge of 16 any employee of the system without first obtaining written consent of the parents / guardians.² 17 Results of all group tests shall be recorded on the students' permanent records and shall be made 18 available to appropriate personnel in accordance with established procedures.⁶ 19 No later than July 31st of each year, the board shall publish on its website information related to 20 state and board mandated tests that will be administered during the school year. The information 21 shall include:⁷ 22 1. The name of the test; 23 24 25 2. The purpose and use of the test; 26 3. The grade or class in which the test will be administered; 27 28 29 4. The tentative date or dates that the test will be administered; 30
- 5. The time and manner in which parents and students will be notified of the results of the test; and

6. How parents can access the questions and answers on their student's state-required tests.
