General

This policy shall apply to sponsors and potential sponsors of charter schools. It shall not apply to charter schools converting from existing public schools. Proposals from existing charter school operators or replicators and applicants proposing to contract with educational service providers shall include the information required by state law.¹

APPLICATION PROCESS²

A prospective charter school sponsor shall send the Director of Schools notice of its intent sixty (60) days prior to February 1st of the year preceding the year in which the proposed charter school plans to begin operation as a charter school.

A sponsor seeking Dickson County Board of Education approval of an initial charter school application shall complete the forms provided by the Department of Education. The application shall provide all the information required by law. The sponsor shall demonstrate that the proposed charter school meets the purpose prescribed by law for the formation of a charter school, and the proposed charter school will be able to implement a viable program of quality education for its students.³

Applications shall be submitted to the Dickson County Board of Education and Department of Education on or before 4:30 p.m. on February 1st of the year preceding the year in which the proposed charter school plans to begin operation as a charter school. If the 1st of February falls on a Saturday, Sunday, or holiday on which the school district offices are closed, applications will be accepted on the next business day on or before 4:30 p.m. Late applications will not be accepted, without exception. The sponsor shall pay an application fee of \$2,500.00.²

REVIEW TEAM¹

If necessary, the Dickson County Board of Education shall appoint a review team to assist in reviewing and evaluating charter school applications. The team shall be comprised of members of the administrative staff for the district, community members, and a member of the Dickson County Board of Education with relevant educational, organizational, financial, and legal experience. If necessary, the Director of Schools shall make a recommendation to the Dickson County Board of Education on which members of his/her administrative staff should be appointed to the team. The Dickson County Board of Education shall name the members of the team at its meeting in January of each year. The Dickson County Board of Education shall designate a Chair of the review team as the contact person for answering questions about the application process and receiving applications. The Director of

Schools shall develop an orientation for the team to ensure consistent evaluation standards and the elimination of real or perceived conflicts of interest

The Dickson County Board of Education shall require the Director of Schools to develop a procedure for receiving, reviewing, and ruling on applications for the establishment of charter schools by the review team. The procedure shall include a timeline for the application and review process. A copy of the procedure, including the review criteria, shall be available to any interested party upon request.

The review team shall:

1. Evaluate all charter school applications based on the review criteria adopted by the Dickson County Board of Education;
2. Recommend one of the following options to the Dickson County Board of Education for each application: approve, reject, or reject with stipulations for reconsideration; and
3. Make recommendations for revocation, renewal, or non-renewal of charter school contracts.

APPROVAL/DENIAL OF APPLICATION⁴

The Dickson County Board of Education shall rule by resolution on the approval or denial of a charter school application within ninety (90) days of receipt of the completed application, or the application shall be deemed approved by law. The Director of Schools shall report the action taken by the Dickson County Board of Education to the Department of Education.

Approval

The sponsor of a charter school that is approved by the Dickson County Board of Education shall enter into a written agreement with the Dickson County Board of Education which shall be binding on the charter school's governing body. The charter school agreement shall be in writing and signed by the sponsor and the Dickson County Board of Education.

The Dickson County Board of Education will receive an annual authorizer fee of three percent (3%) of the annual per student state and local allocations or thirty-five thousand dollars (\$35,000), whichever is less.⁵

Charter schools approved by the Dickson County Board of Education are expected to implement the application as submitted and approved. Material variations in operations from the approved application require amendment pursuant to statute and the charter school agreement.

The Dickson County Board of Education shall not provide services to charter schools that are not requested during the application process except for those services that are required under state or federal laws. Services agreed to be provided to the charter school by the Dickson County Board of Education shall be provided at Dickson County Board of Education actual cost. The Dickson County Board of Education and charter school shall execute a service contract for any additional services.

1 New charter school agreements are approved for a ten (10) year period.⁶ The Dickson County Board of
2 Education may revoke or deny renewal of a charter school agreement for any of the reasons
3 enumerated in state law.⁷

4 *Denial*

5 Upon written receipt of the grounds for denial, the sponsor shall have thirty (30) days within which to
6 submit an amended application to correct the deficiencies. The Dickson County Board of Education
7 shall have sixty (60) days either to deny or to approve the amended application, or the application shall
8 be deemed approved by law.⁴

9 Within ten (10) days of final denial, an appeal may be filed with the State Dickson County Board of
10 Education of Education.
