

# White Bluff Elementary School Parent and Family Engagement Policy 2021-2022

## JOINTLY DEVELOPED

White Bluff Elementary School will take the following actions to involve families in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by families, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

Parent involvement for WBES is based on the belief that families have a major influence on their child's educational decisions as well as providing opportunities for participation of all parents. We believe that purposeful and intentional communication among all stakeholders cultivate a culture for better student results. WBES has moved to create focused opportunities for collaboration with parents and guardians, and community members. WBES offers multiple opportunities for parents to learn to help their children meet state academic standards at high levels. WBES offers two workshops for parents to help their children be successful in school. Workshops are offered based on parental input through surveys and committee meetings. Additional opportunities are given to help children succeed through open house, book fairs, science fairs, as well as volunteer programs for parents to help their child's classroom or assist in the activities. WBES has an open communication policy, parents are welcome to all virtual or in-person meetings, and information is disseminated concerning making decisions about their child's education. Annual surveys are sent out to all parents to obtain information about Title I programming successes, improvements and ideas for helping students succeed in school.

#### ANNUAL TITLE I MEETING

**White Bluff Elementary School** will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all families of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the families' requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent compact.

WBES will hold the Annual Title I meeting to inform parents and families of the requirements of Title I schools and inform parents of their right to be involved. The parent and family engagement policy is distributed to families each year at the beginning of the school year during the registration process, discussed during open house and during the annual meeting. School communication will include frequent two-way communication with families about student learning. Communication will be facilitated through the Weekly Folders, updates on the school website and Skyward, Parent newsletters, Parent-Teacher Conferences, Phone calls, emails, or notes sent home, Intouch messages, Class DoJo messages, RTI benchmark assessment and Fastbridge progress monitoring results are sent home, Encase assessment and weekly assessment results, Report cards and progress reports as well as Grade level objectives sent home. Meetings and information are translated as needed.

WBES has allocated \$2,157.90 for parent involvement. The budget for family engagement is developed jointly with parents during the spring budget meetings. Expenditures are discussed and obligated based on the fall parent involvement meeting. Parent workshops and activities are developed based on survey and parent input during the fall meeting.
